The TLP3106 photorelay consists of a photo MOSFET optically coupled to an infrared light emitting diode. It is housed in a 2.54SOP6 package. The low ON-state resistance and the high permissible ON-state current of the TLP3106 make it suitable for power line control applications.










Fig. 11.1 Switching Time Test Circuit and Waveform




Fig. 12.2.1 A Connection




Fig. 12.2.3 C Connection





Fig. 12.2.2 B Connection


